

Baptism Policy

- 1. St Andrew's affirms and upholds the historic teaching of the Church of England, as part of universal Church of God, that Baptism is a sacrament (an outward sign of God's inward activity in our lives) whereby God works in us the forgiveness of our sins, the gift of new life in Jesus Christ through the Holy Spirit and membership of the Church, which is understood to be the Body of Christ on earth.
- 2. As a church, we place a high value on the importance of Baptism and on the commitment required by it of being an active part of the life and worship of the church community. As such, we recognize that Baptism is not appropriate for everyone and we are committed to offering those who wish to mark the gift of a child or the start of a journey in the Christian faith an alternative means of doing so, such as a service of Thanksgiving for the Gift of a Child.
- 3. In celebrating Baptism, we affirm the following principles:
 - 1. We delight to receive and welcome all who wish to explore Baptism for themselves or for an infant.
 - 2. We are committed to affirming, encouraging and nurturing all candidates to become confident and committed followers of Christ through the hospitality, pastoral care and worshipping life of the church community.
 - 3. We will ensure that candidates for Baptism are sufficiently prepared for the commitments they will be asked to make and are able to make their promises with understanding and integrity.
 - 4. We believe that Baptism means being made members of the Church, therefore we want all baptismal candidates to feel comfortable and at home at St Andrew's as their church family and the community who will support them in their journey of faith.
- 4. Baptism at St Andrew's is available to anyone who:
 - 1. is resident in the parish of St Andrew Radcliffe.
 - 2. is on the electoral roll of St Andrew Radcliffe.
 - 3. has been in regular attendance of worship at St Andrew's, for a period of at least three months.

- 4. does not meet these criteria, but is able to demonstrate to the clergy strong and exceptional reasons why they should be baptised at St Andrew's, Radcliffe (given the consent of the incumbent in whose parish they are resident).
- 5. Baptism enquiries should be made through the Baptism co-ordinator, Mrs Diane Moran (Email: diane.moran1@btinternet.com or Telephone: 07565 503830).
- 6. The date on which a Baptism will take place is determined at the discretion of the clergy in consultation with candidates and/or parents during one of the main Sunday acts of worship and will be advertised at least one week in advance.
- 7. For the Baptism of an infant:
 - 1. Parents and godparents are expected to be both baptised. Where one or both parents are not baptized, it is essential that all the child's godparents are both baptised and ideally regular worshippers at this or another church.
 - Children will normally have three godparents (of whom two should usually be of the same sex of the child to be baptised and one of whom may be a parent of the child to be baptized), though a child should have no less than two godparents, one male and one female.
 - 3. It is the responsibility of the clergy to ensure that parents (and godparents,) receive sufficient teaching about Baptism to help them make the promises required of them with good understanding and intention.
- 8. For the Baptism of an adult:
 - 1. Candidates will be encouraged to consider Confirmation at the same time as their Baptism.
 - 2. Candidates may nominate baptised sponsors to support and encourage them in their journey of faith.
 - 3. Clergy will ensure that candidates receive sufficient instruction to prepare them for the step of faith they will make.
- 9. In accordance with the doctrine and practice of the Church of England, we will not rebaptise anyone who has already received a valid Baptism with water in the name of the Holy Trinity, whether in the Church of England or a recognized ecumenical partner of the Church of England; however, in situations where it is unclear whether a person has already received a valid Baptism, it is possible to perform a Conditional Baptism.
- 10. This Baptism Policy is not in any way intended to replace or supersede the requirements incumbent upon the parish and clergy under the Canon Law of the Church of England; rather, this Policy is intended to clarify how the Canon Law of the Church of England is interpreted and applied in this parish.
